**COUNCIL OF THE COLLEGE OF PHYSICIANS AND SURGEONS

IN THE MATTER OF JOSEPH ARDITTI, MD**

**ORDER OF COUNCIL**

**UPON THE MEETING OF THE COUNCIL** on September 11, 1998, in the city of Saint John, New Brunswick, with respect to the matter of Joseph Arditti, MD, of Saint John, New Brunswick;

**UPON HAVING** investigated allegations of professional misconduct against Joseph Arditti, MD;

**WHEREAS** the parties have agreed to forego a proceeding by way of a Board of Inquiry and proceed directly to Council;

**AND WHEREAS** Joseph Arditti, MD, through his legal counsel, Rodney J. Gillis, QC, of Saint John, New Brunswick, has admitted professional misconduct;

**COUNCIL THEREFORE FINDS** Joseph Arditti, MD, guilty of professional misconduct under s.56(c) of the *Medical Act*, S.N.B. 1981, c. 87 and amendments thereto;

**AND UPON CONSIDERING** the submissions of Rodney J. Gillis, QC, on behalf of Joseph Arditti, MD, and John P. Barry, QC, counsel for the College of Physicians and Surgeons of New Brunswick, with respect to both the admission of a guilty plea and penalty;

**AND UPON CONSIDERING THAT** Dr. Arditti has retired from clinical practise and has agreed to voluntarily relinquish his license to practise medicine, and has furthermore agreed not to seek reinstatement of such license, nor to seek licensure in any other jurisdiction,


**IT IS THEREFORE ORDERED THAT** the license to practise medicine of Joseph Arditti, MD, be suspended for a period of one year;

**ALL OF WHICH WAS DULY RESOLVED** by Council as an order of Council of the College of Physicians and Surgeons of New Brunswick, pursuant to the terms and provisions of the *Medical Act*, S.N.B. 1981, c. 87 and amendments thereto.
