IN THE MATTER OF DR. PETER JACKSON

ORDER OF COUNCIL

UPON THE MEETING OF THE COUNCIL on April 15, 1994, at the City of Saint John, New Brunswick, with respect to the matter of Dr. Peter Jackson, of Westfield, New Brunswick;

AND UPON CONSIDERING the Agreed Statement of Facts submitted jointly by the College of Physicians and Surgeons of New Brunswick and Dr. Peter Jackson;

AND UPON BEING ADVISED THAT, on the 8th day of January, 1993, Dr. Peter Jackson was convicted of assault on the person of [REDACTED], contrary to Section 266(b) of the Criminal Code of Canada, in the Provincial Court, Province of New Brunswick;

AND UPON BEING ADVISED THAT [REDACTED] was a patient under the care of Dr. Jackson at the time the assault was committed on April 14, 1992;

AND UPON that conviction being proven to Council by entering into evidence a Certificate of Conviction from the Provincial Court;

AND WHEREAS Council is of the opinion that this conviction relates to Dr. Jackson's suitability to practise medicine;

COUNCIL THEREFORE FINDS that Dr. Peter Jackson is guilty of professional misconduct under section 56(a) of the Medical Act, S.N.B. 1981, c. 87.

AND UPON CONSIDERING the joint submission of the College of Physicians and Surgeons of New Brunswick and Dr. Peter Jackson with respect to penalty;

AND UPON CONSIDERING the fact that Dr. Jackson's privileges at the Saint John Regional Hospital were suspended from April 15, 1992 through July 15, 1992, as a result of this incident;

AND UPON CONSIDERING the fact that Dr. Jackson's practice is hospital-based and he therefore was unable to practise medicine from April 15, 1992, through July 15, 1992;

IT IS THEREFORE ORDERED THAT Dr. Jackson's license to practise medicine be suspended for a period of three months;


IT IS FURTHER ORDERED THAT the suspension of privileges served by Dr. Jackson from April 15, 1992 through July 15, 1992, be substituted for the suspension of license ordered by Council and that Dr. Jackson shall serve no further suspension.

ALL OF WHICH HAS BEEN DULY RESOLVED by Council as an Order of Council of the College of Physicians and Surgeons of New Brunswick, pursuant to the terms and provisions of the Medical Act, S.N.B. 1982, c. 87.
